## PRIVACY POLICY

TECHNOCAD S.A., headquartered in Baia Mare, 72 Vasile Alecsandri, with Trade Register number J24 / 255/1998, VAT ID RO10445707, tel. 0040-262-215156, email office@technocad.ro taking into consideration the provisions of the (EU) 2016/679 Regulation of the European Parliament and of the Council from 27 April 2016 on the protection of individuals with regard to the processing of personal data and the free movement of these data, as an operator, please note the following:

- 1. We comply with the legal provisions on the protection of personal data and implement technical and organizational measures to protect all operations relating directly or indirectly to personal data that prevent unauthorized or unlawful processing as well as accidental or illegal loss or destruction.
- 2. We will process your personal data for the following purposes:
  - Performance of contract with the legal entity on behalf of which you act and for the fulfillment of our obligations as a contracting party, as well as for communication with you;
  - Communicating with you in order to prepare an offer or contract;
  - Compliance with applicable rules, legal regulations, codes of conduct or guides, or law enforcement and cooperation with competent authorities;
  - in order to satisfy legitimate interests, such as:
    - cooperation with public authorities and institutions;
    - managing and preparing internal reports.
- 3. To accomplish the above-mentioned purposes, TECHNOCAD S.A. uses the services of several contractual partners. We may provide your personal data to our contractual partners, service providers.

Some of them are third parties who do not have the role of processing personal data but may have access to them in order to fulfill their obligations or in their interaction with TECHNOCAD S.A., such as technical maintenance, financial auditors or legal service providers.

We make every effort to ensure that all entities we work with, store your personal data safely and securely. Personal data may also be made available or transmitted to third parties in the following situations:

- (i) public authorities, auditors or competent institution to control activities or assets of the Company which requires the company to provide information, based on legal obligations incumbent on society. Such public authorities or institutions may be the National Agency for Fiscal Administration, the Ministry of Finance, the National Anticorruption Directorate, units of the Ministry of Internal Affairs;
- (ii) to meet a legal requirement or to protect the rights and assets of our Company or other entities or persons, such as courts of law;
- (iii) third acquirers party, to the extent that the Company's activity would be (wholly or partly) transferred and personal data to the data subjects would be part of the assets being the subject of the transaction.
